EurAsia Conformity (EAC) Certification

Gain product approval for the Customs Union market

Those wishing to export consumer and industrial goods to the Eurasian Economic Community countries of Russia, Belarus, Kazakhstan and Armenia*, must ensure that their products meet a wide range of technical regulations to gain the EurAsian Conformity Mark (EAC Mark).

As the individual national regulations are progressively replaced with the harmonised standards of the Customs Union, many manufacturers are left confused about the correct route to compliance.

What is EAC certification?

The EAC Mark is a mandatory mark that must be affixed on a product to demonstrate its compliance to the Customs Union standard. Examples of products that are subject to a mandatory conformity assessment include electrical and electronic appliances such as lighting, household appliances and batteries.

The Customs Union is a fast growing export market, representing significant revenue generation opportunities for overseas manufacturers of industrial and household equipment. EAC certification allows businesses to successfully exploit new market opportunities by trading freely with Russia, Belarus, Kazakhstan and Armenia.
